I will further read and comply with all the Stuart Singlefin Showdown rules and regulations, and do agree that, noting existing weather conditions, I voluntarily assume all risks arising from conditions related to use of the contest site by myself and others. I give the Stuart Singlefin Showdown permission to arrange to telecast, show, or print and publish any and/or all pictures taken of me (movie, video, or still) in conjunction with said event.
